Statutory provisions under Maharashtra fire prevention and life safety measures act, 2006

1. Under Section 3 of "Maharashtra Fire Prevention & Life Safety measure rules 2006" (here in after referred to as "Said Act"). The applicant (developer, owner, occupier by whatever name called) shall comply with all the fire and life safety measures adhering to national building code of India 2005 and as amended from time to time failing which it shall be treated as a violation of this said act.

2. It is presumed that you have completed the work adhering to the provisions under Section 3 of the said act.

3. Under Sub Section (3) of Section 3 It is responsibility of the owner of the occupier as the case may be shall furnish to the Chief Fire Officer or nominated Officer a certificate in prescribed form twice a year in the month of January & July regarding maintenance of Fire Prevention & Life Safety measure in good repair and efficient condition as specified in Sub Section 1

4. Under Sub Section (4) of Section 3 No person shall tamper with alter remove or cause any injury or damage to any Fire Prevention & Life Safety equipment installed in any such building or part there of or instigate any other person to do so.

The Fire Fighting System provided by you in the premises as per Provisional No-Objection Certificate shall be well maintained & shall be kept in tip-top working condition at all the time. If the fire protection system is not maintained, retrenched then this "N.O.C." will stand cancelled without any notice & you will be solely responsible to loss of life or property if any, which may please be noted.

The condition mention in the "Provisional No Objection Certificate" will remain unchanged the undersigned reserves right to amend any additional recommendations deemed fit during the stage wise inspection due to the statutory provisions amended from time to time and in the interest of the protection of the company. If any change of activity or Transfer of plot or any future expansion, No Objection Certificate from this office is essential.
